Fribourg, October 13, 2022 Invitation to the ELPIS Conference in Fribourg

Dear Colleagues and Friends,

After almost two years of online and limited contacts, it is my very great pleasure and honour, on behalf of the Faculty of Law of the University of Fribourg, to invite you to the *2021 ELPIS conference*. The conference will take place face-to-face **on 9 – 11 December 2021**.

You may remember that in last year's invitation, we had the possibility to offer accommodation and participation to the travel of the participants from EU Countries Faculties. Our request for funding at the National Agency is still pending. Of course we will inform you as soon as we have further information and we hope that it will be good news. As Switzerland is currently not an official member of the Erasmus+ programme, unfortunately it won't be possible to cover the entire expenses for travel to Switzerland with Erasmus funds.

In the application form, you will see that an *International Market – Information to students* has been introduced. This might be one of the conditions to fulfil to receive funding from our National Agency. I already thank you for agreeing to participate.

Unfortunately we will not be able to offer travel expenses and accommodation to the partners from faculties from non EU-countries. I hope that despite that, we will have the pleasure to welcoming you to Fribourg at this occasion.

Regarding the accommodation, we pre-booked rooms at the following hotel:

• Hotel de la Rose:

- 5 single rooms at the special university rate of SFr. 121.10, including breakfast.
- 15 double rooms with single use at the special university rate of SFr. 142,10, including breakfast.
- If the room is booked as a double room, the special university rate is SFr. 166,20, including breakfast.

The hotel is located in the upper part of the old town, Rue de Morat 1.
