The Jean Monnet Eucons is organizing the **Forum on the Future of Europe**, an international meeting of scholars of European constitutional law, mainly from Southern Europe, in order to debate and exchange ideas on the future of the Union with the aim of creating a Decalogue "Towards a Europe of Citizens". On the 15th anniversary of the Treaty of Lisbon, we will gather in Lisbon to present proposals for the future of Europe around four main topics: 1) Constitutional Identity and State of Law; 2) Economy, Technology and Defense; 3) Institutional Reforms; 4) Environment, Energy and Health. These topics will be discussed in four round tables taking into account the intergenerational dialogue. Afterwards, the participants will be divided in specific working groups in order to draw the Decalogue, which will be presented in Brussels at the spring of 2023.
