ANNUAL MEETING

- I. INTRODUCTION
- Approval of the minutes of the 15th. December 2021 Annual Meeting (via Zoom).
 The approval was by unanimity.

- Short presentation of the participants: At the request of Prof. Vasco Pereira da Silva, all representatives present introduced themselves and expressed joy for participating in this meeting.
- Admission of Associate Members: SEALS, Louisville U. (Lib. O. Prog.).
 The approval was by unanimity.
- II. ELPIS NEWS. The Members talked about shared their experiences coming out of the most complicated pandemic times. Numbers of exchange are on the raise again but still not as they used to be before Covid-19. This point was connected to the following.
- III. ELPIS EXCHANGE OF STUDENTS, PROFESSORS AND STAFF. Continuing the previous discussion, special consideration was given to the situation in Ukraine. Prof. Vasco Pereira da Silva and Prof. Rui Guerra da Fonseca explained the program hosting Ukrainian students in Lisbon. Concern was expressed by other partners on what to do regarding both Ukrainian and Russian students and how universities should deal with that. At the end, there was some consensus on not "closing" programs for any students, but taking under consideration the different situations in which the various institutions are placed.
- IV. ELPIS IN THE WORLD: Participations in the SEALS CONFERENCE of 2022 was discussed, as well the Transatlantic Lectures Series. This experience was explained and its results given by Prof. Vasco Pereira da Silva as an example of how transatlantic cooperation works well and should be enhanced. Students research exchange.
